# ABOUT THE ALABAMA INVESTIGATOR ACADEMY

With the approval by the Alabama
Peace Officers Standards and Training
Commission (APOSTC), an 80-hour
curriculum was developed, and the
Investigator Academy was created.
The training curriculum was based on
responses from law enforcement personnel
regarding topics that they felt were needed.
Modules in the curriculum include Crime
Scene Procedures, Death Investigation,
Interviewing Techniques, Criminal Law
Procedures, and Case File Preparation, and
Courtroom Testimony.



# BASIC ALABAMA INVESTIGATOR ACADEMY CURRICULUM

The basic Alabama Investigator Academy spans a series of four months. Each month is categorized as a block and meets no more than a three-day period. Below is a break down of the classes you will take each block:

### Block 1:

» Criminal Investigations, Crime Scene Processing, Trace Evidence, Imprint & Impressions, and Advanced Crime Scene Processing

### Block 2:

» Crime Scene Photography

### Block 3:

» Death Investigations, Digital Evidence, and Interview and Interrogations

### Block 4:

» Casefile Preparation, Criminal Law, and Courtroom Testimony

### CERTIFIED INVESTIGATOR

Upon completion of the Alabama Investigator Academy, Investigators receive the title of a *Tier One* Certified Investigator.

Continuing education classes are then offered to investigators who wish to specialize in varies types of investigation work.

Once an investigator receives 240 hours in classroom/training setting, they receive the designation as a *Tier Two* Certified Investigator.

Once an investigator receives 360 hours in classroom/training setting, they receive the designation as a *Tier Three* Certified Investigator.

For those wanting continuing education hours credited for classes not taught by the Alabama Investigator Academy, they may submit their training to the Advisory Board for review. The Advisory Board is made up of law enforcement leaders across the state of Alabama.
