

**Coronavirus Aid, Relief, and Economic Security (CARES) Act
Higher Education Emergency Relief Fund (HEERF) - Student Portion
Required Reporting & Disclosure
June 18, 2020**

- 1) Jacksonville State University (JSU) acknowledges that the institution has signed and returned to the U.S. Department of Education the Certification and Agreement for the Student Portion of the HEERF on April 8, 2020. JSU will use no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
- 2) The total amount of funds awarded to JSU that JSU will receive or has received from the U.S. Department of Education pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students is \$3,025,320.
- 3) The total amount of Emergency Financial Aid Grants distributed to students under section 18004(a)(1) of the CARES Act by JSU as of June 18, 2020 is \$2,326,134.
- 4) The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 5432 students.
- 5) The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act is 3182 unique students.

 - c. Draw #3 309 Phase I students, \$223,200; 35 Phase II students, \$19,050
 - d. Draw #4 245 Phase I students, \$172,800; 15 Phase II students, \$10,084
 - e. Draw #5 47 Phase I students, \$34,000.
