

**Coronavirus Aid, Relief, and Economic Security (CARES) Act
Higher Education Emergency Relief Fund (HEERF II) - Student Portion
Required Reporting & Disclosure
June 30, 2021**

- 1) Jacksonville State University (JSU) acknowledges that the institution has signed and returned to the U.S. Department of Education the Certification and Agreement for the Student Portion of the HEERF on April 8, 2020. JSU will use no less than 50% of the funds received CRRSAA and ARP (a)(1) and (a)(4) to provide Emergency Financial Aid Grants to students.
- 2) The total amount of funds awarded to JSU that JSU will receive or has received from the U.S. Department of Education pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students is \$3,025,320 for HEERF I, and \$3,025,320 for HEERF II making the total awarded \$6,050,640.
- 3) The total amount of Emergency Financial Aid Grants distributed to students under CRRSAA and ARP (a)(1) and (a)(4) by JSU for the quarter ending:
 - a. March 31, 2021 is \$2,637,450
 - b. June 30, 2021 is \$240,200
- 4) The estimated total number of students at the institution eligible to receive Emergency Financial Aid Grants to students under CRRSAA and ARP (a)(1) and (a)(4) is 8002 students.
- 5) The total number of students who have received an Emergency Financial Aid Grant to students under CRRSAA and ARP (a)(1) and (a)(4) is 6053 unique students.
- 6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive are as follows:
