INTRODUCTION

The Psychology collection is adequate to support the courses taught in the Bachelor’s and Master’s degree programs, as well as the course taught in the Psychology minors. The Psychology Collection complements and supports study in other disciplines, including social work, counseling, nursing and allied health, educational psychology, social psychology, and biology. Complete conspectus sheets and checklists are available upon request for a more detailed examination of the collection.

HOLDINGS

The Psychology collection contains **9,823** titles in BF, and **5,185** in RC call number ranges 321-571, including **7,156** e-books. Total monograph expenditures for Psychology from FY 2017/18 to FY 2020/21 were **\$47,319.68** with 543 new titles added. These newer additions comprise 3.6% of the current Psychology collection. Since the last collection assessment, books in the BF call number area have been relocated to the 9th floor, which also houses the clinical psychology collection in RC.

These numbers represent a snapshot of the collection, as titles are continually being added and withdrawn for collection maintenance and growth. These numbers do not represent additional titles available through e-book databases.

PERIODICALS AND SERIALS

The Library has access to full-text journals available throughout the Library databases. There are approximately 1,364 journals in Psychology and related subjects available electronically through database subscriptions, which can be found in EBSCO's Publication Finder at <http://bit.ly/2zO6DjD>. The Serials expenditures in Psychology for both print and electronic subscriptions and standing orders average **\$33,168.33** from FY 2017/18 to FY 2020/21 (see table below.)

INTRODUCTION

The Psychology collection is central to the University curriculum, since it supports study for degree programs in Psychology and Applied Behavior Analysis at the Bachelor's and Master's levels offered by the College of Social and Behavioral Sciences. The collection also supports a minor in Psychology. The Psychology collection is adequate to support the courses taught in the Bachelor's and Master's programs. Complete conspectus sheets and checklists are available upon request for a more detailed examination of the collection.

HOLDINGS

The Psychology collection contains **9,823** titles in BF, and **5,185** in RC call number ranges 321-571, including **7,156** e-books. Total monograph expenditures for Psychology from FY 2017/18 to FY 2020/21 were **\$47,319.68** with 543 new titles added. These newer additions comprise 3.6% of the current Psychology collection. Since the last collection assessment, books in the BF call number area have been relocated to the 9th floor, which also houses the clinical psychology collection in RC.

These numbers represent a snapshot of the collection as titles are continually being added and withdrawn for collection maintenance and growth. These numbers do not represent additional titles available through e-book databases.

SUMMARY

Strengths:

Total holdings, conspectus evaluation, and checklist comparisons indicate the overall Psychology collection is more than adequate to support the curriculum. Of note on the conspectus worksheet are strong holdings in the subject areas of: Child Psychology, Applied Psychology, Neurosciences and Psychiatry.

A review of the journal holdings reveals that the Psychology collection, and supporting collections in nursing and allied health, education psychology, social psychology, and biology are adequate to support the curriculum.

Weaknesses:

Total holdings, conspectus evaluations, and checklist comparisons indicate that some areas still need development. These are: Professional Issues-Licensure/Certification, Professional Issues-Economic of Practice, Psychology of Nations, National Characteristics, and Psychology of Special Groups. In addition, some holdings in Psychiatric Nursing are outdated and need to be replaced when budgets allow.

Recommendations:

The growth rate of the Psychology Collection should be maintained in order to continue providing support for the undergraduate and graduate programs in Psychology. The monograph collection should be generally increased, based on budget, with a strong focus on core and outstanding titles. The periodical collection available from electronic databases is substantial and should be maintained. The weak subject areas (noted above) should also be addressed in future additions to the collection.
