### **INTRODUCTION**

The Western European Literatures collection is adequate to support the courses taught in the Bachelor's and Master's programs in English, Foreign Languages, and Secondary Education, which incorporate the collection into their curricula. Complete conspectus sheets and checklists are available upon request for a more detailed examination of the collection.

## **HOLDINGS**

The Western European Literatures collection contains **13,680** titles in the PQ and PT call number ranges, including 3,360 e-books. Total monograph expenditures for Western European Literatures from FY 2017-2018 to FY 2022-2023 were **\$167,633.42** with 419 new titles added. These newer additions comprise 3% of the current Western European Literatures collection.

These numbers represent a snapshot of the collection as titles are continually being added and withdrawn for collection maintenance and growth. These numbers do not represent additional titles available through e-book databases.

The Western European Literatures collection is central to the University curriculum, since it supports study for the degree program in Foreign Languages at the Bachelor's level and degrees in English at the Bachelor's and Master's levels offered by the School of Arts and Humanities, as well as the Bachelor's and Master's degrees in Secondary Education offered by the school of Education. The collection also supports minors in these areas along with the degree in the major field. ## <u>SUMMARY</u>

## Strengths:

Total holdings, conspectus evaluation, and checklist comparisons indicate the overall Western European Literatures collection is more than adequate to support the curriculum. Of particular note on the conspectus worksheets are the holdings in the subject areas of French Literature, Spanish Literature, and German Literature. However, because the collection is not central to a degree program, the strength of the collection cannot be measured across its entire spectrum but must be determined based on individual authors and works as they complement courses in the degree programs of Foreign Languages and English.

A review of the journal holdings reveals that the Western European Literatures collection is adequate to support the curriculum.

## Weaknesses:

Total holdings, conspectus evaluations, and checklist comparisons indicate that the weakest areas of the Western European Literatures Collection subject areas are related to provincial, local and colonial categories. Canon expansion mandates that acquisitions emphasis be moved from the traditional core to post-colonial authors and works, particularly those of the twenty-first century. These are the things finding their way into the curriculum more and more (the same is true of Asian and Eastern European writers), and because this is a recent development this part of the collection is the weakest. It should be kept in mind that the areas with the smallest holdings are so largely because they are out of scope for the curriculum.

## **Recommendations:**

The growth rate of the Western European Literatures collection should be maintained to continue providing support for majors and minors in the degree programs of English, Foreign Languages, and Secondary Education. The monograph collection should be selectively increased, based on budget and the curriculum, with a strong focus on core and outstanding titles. The periodical collection available via databases is substantial

and should be maintained. The weak subject areas (noted above) should also be addressed in future additions to the collection. At present, this strengthening focuses on literatures of former colonies of the Western European nations, as authors from these nations are receiving a higher profile in the curriculum.

Since canon expansion mandates that emphasis be moved from the traditional core to post-colonial authors and works, particularly those of the twenty-first century, areas that complement the degree programs the most will be heavily selected. Because this is an area of weakness in the collection, developing the collection to reflect more of the post-colonial authors and their works can bridge gaps of literature that might be appropriate complementary works for courses or assignments. However, awareness and attentiveness by the subject specialist will ensure the collection will be strengthened in appropriate areas as the curriculum evolves. The focus should be on literatures of former colonies of the Western European nations, as authors from these nations are receiving a higher profile in the curriculum.
